### **Course description**

This course will familiarize students with the issues surrounding concepts of crime, criminals, crime typologies, and societal responses to crime. Students will examine the theoretical, methodological, and policy issues in criminology and criminal justice.

### **Course objectives**

On successful completion of this course, you will be able to:

1. Examine the historical evolution of criminological theory;
2. Recognize the basic concepts associated with criminological theory;
3. Recognize and examine the advantages and disadvantages of the major sources of data on crime trends and patterns collected by the Bureau of Justice Statistics and Office of Justice Programs, and the National Criminal Justice Reference Service;
4. Assess the empirical status of the five major criminological theories (Classical, Rational Choice, or Deterrence; Positivist, Strain, Social and Self-Control, and Social Learning);
5. Examine theoretical developments in criminology including Critical Criminology, Feminist Criminology, Reintegrative Shaming, and Developmental or Life Course Criminology.
6. Examine crime typologies and/or activities including white-collar crime, organized crime, cybercrime, hate crimes, terrorism, homeland security, and drugs.

### **Course required text and materials**

**A. Quizzes (25% of grade):** There will be a quiz for every chapter. Each quiz will have True/False, multiple choice and short answer. Responses for short answer questions should be well thought out and written in correct grammatical form. Spelling will be graded. Students are expected to take the quizzes by themselves. These will be timed quizzes so be prepared, once you begin you may not exit and return, it has to be completed. Quizzes will be opened on **Fridays by 1pm and will close on Sunday by 8pm. There are no make-up quizzes! Failure to access quizzes, assignments or Exams in a timely manner is not an excuse.**

**B. Discussion Board Assignment (10% of grade):** There will be a discussion board question posted every **Monday**, you will have until the following **Thursday** to do your original post, each student will also be required to comment in a meaningful way on at least 2 posts by Friday of that week. Discussion Board is worth 10% of total grade, 5% for original post, and 5% for responses. You are expected to keep up with the discussion board on your own.

**C. Midterm Exam (20% of grade):** The midterm exam will cover questions from Chapters 1-8.

**D. Final Exam (20% of grade):** The final exam will cover questions from Chapters 9-15.

**E. Class Assignments (25% of grade):**

Assignments must be submitted by the deadlines set, no exceptions, late work will not be graded.
