**Required Text:** The World of Psychology, 7th Edition, Wood.

**Purpose of Course:** This course is an overview of Psychology. It includes biology, behavior, sensations, consciousness, learning, memory, language, intelligence, human development, motivation & emotion, sexuality (human) & gender, health/stress, personality theories, psychological disorders, therapies, and social psychology. Each of these topics is a course or study of its own, however, this semester the student (you) will look at each, and understand ‘the tip of the iceberg’ for each area.

**Grading:** Grades will be based on:

- 1) a) Attendance; b) Weekly Discussion Board Comments; & c) Suicide Prevention Course (online) (1/5 grade);
- 2) Class Presentation (1/5 grade);
- 3) Two Research Papers (1/5 grade);
- 4) Mid-Semester Exam (1/5 grade);
- 5) Final Exam (1/5 grade).

Class participation will be considered for students whose final grade is on the ‘cusp’ between two major grades.

**GRADE SCALE:** 90–100 = A; 80–89 = B; 70–79 = C; 60–69 = D; 0–59 = F

- Activities Explained:**
- 1) a) **Attendance:** Each class day students will sign their own names on the roll sheet that is passed around the class. The names are in alphabetical order (by last name), so find your name and sign there. Attendance is important, so make sure your name is on the roll sheet each day you are in attendance. It is the student’s responsibility to make sure you sign your name on the roll sheet if you are present for class. **Having another student ‘sign-in’ for you (when you’re missing a class) will result in disciplinary action for BOTH students (so don’t do it!).** Students will be dropped from the class after missing nine class periods (university policy), unless discussed with Wren, is considered a university excused absence, and the reason must be documented (proof required).
  - b) **Discussion Board Comments:** Due every Fridays by MIDNIGHT. These are your thoughts about what you learned throughout that week. You will be graded on your personal reflection/reaction to what you learned. Responding to other students’ comments will get you some bonus points IF it is acceptable thoughts. **I will NOT accept late work.**
  - c) **Suicide Prevention Course:** Complete the Kognito Suicide Prevention course at <https://texas.kognito.com/> Make an account for yourself: put in your first name, last name, and Sul Ross email address, then make your own password. After that is completed go to the drop-down menu under, “Choose Your Training POV” and click on ‘University or College Students/RA,’ and complete the Student Training. When completed, print or save a downloaded ‘completed certificate,’ and either hand in (hardcopy you printed) to Wren, or POST IT ON BLACKBOARD: ASSIGNMENT.

- Activities Explained:** 2) Class Presentation: Each student will participate in a group presentation when assigned to do so. Presentations will cover the subject chosen, and **incorporate audio and visual** (from Internet or other sources) examples, may include power-point presentations, etc. Presentations will be for 20-30 minutes. A written outline of the presentation will be given to Wren at the start of the presentation. Wren will discuss this in further detail in class.

- 3) Two Research Papers: The first is due **Monday, September 19, 2016**, and the second is due **Monday, October 31, 2016**. These papers will be over a subject in psychology. Please email Wren (see above) with the subject for approval before you get started. Three (minimum) to five (maximum) pages each paper, double spaced, no larger than 12 pt. font. Post your papers as an attachment to Blackboard/Assignments by NOON on the dates due. You may turn them in sooner, if you wish. **I will NOT accept late work.**
- 4) Mid-Semester Exam: Monday, October 17, 2016.
- 5) Final Exam: Comprehensive. Exact date and time will be announced later (December 2, 5, 6, or 7).
