If you open that first and then go to the NAEYC website and read the article you are taking time from the 2 hour limit. **Remember, the Chapter Assignment section is open for 2 hours.** Other activities may have different times. Check how long you have to complete the assignment so that you can complete the exercise.

You have the week to complete the chapter's assignments. Before you begin an assignment on blackboard, make sure and check the amount of time allotted for the activity. All assignments, quizzes, puzzles, and tests are forced completion. The time for each assignment is provided as you begin the activity. After the time allotted ends these assignments end, thus forcing completion. That is another word for timed.

You have only one opportunity per assignment. It is highly recommended that you go to your campus to do your work. Cell phones, tablets, and other such devices are not generally supported for use with blackboard and problems with connectivity will not serve as justifications for missing assignments. Home Internet outages are not valid defenses; come to your campus where there are technicians who can help if you have computer issues. If you choose to work from home, you have no technical support and no acceptable or valid reasons for not getting things done on time.

Field Experience

You will be required to conduct 5 hours of field observations. There is a form to accompany the field experience provided to you. You must arrange these observations with an administrator of the institution or agency in which you will conduct the observation prior to the actual observations. Dress as a professional and conduct yourself in a professional manner at all times. Make sure your form is signed by the person in charge of the agency and has the time you began your observation and the time the observation ended.

Failure to complete the field observation(s) component of this course will drop your final grade by one letter grade. TURN off YOUR CELL PHONES. Any report that you were using a cell phone during this field experience will result in no credit for the assignment.

Field experience forms are due on **November 18 at 12:00 pm noon.** You may scan the forms and e-mail them to me, or send them through campus mail by the due date.

Your field experience will include attached 1 page summaries for **each of your hours** of observation. Your summaries should include the following:

- 1. sketches of observed room arrangement and analyze the impact on the learning environment;
- 2. observation of the approaches for classroom management, and compare them to materials and activities from the course:
- 3. discussion of the relationship of the classroom environment both physically and emotionally to the concept of Developmentally Appropriate Practice
- 4. descriptions of the difference between Rules and Procedures to help learning occur in the observed class setting;
- 5. sketches of computer generated pictures of what you would consider the ideal classroom setting- include the rules you would use in the ideal classroom setting.

The grade for each of these assignments will be added to your class grade.

Practice TEXES PPR

You are required to take the practice tests for the PPR PreK-6th. The TExES study guide for Pedagogy and Professional Responsibilities EC-12 Tests is located at http://www.sbec.state.tx.us. There is also a good study guide found on black board. Failure to complete this task will result in a 10 point reduction of your final grade. This must be completed by **November 22 at 12:00 noon.**

You may take the practice test at your individual site, or you may take a paper/pencil test in Uvalde.

There is a website that will tutor you in the PPR and provide a certificate to verify that you have completed the tutorial. This site is https://pact.tarleton.edu/TCERT/. The site requires you to sign up for the free service with a user name and a password. To obtain a TEA ID, which is required to get the user name and password, go to the TEAL website where there is a link to get one.

An account with TEA is required before you are able to take the real TExES tests, so many of you may already have this ID. If you do not have the ID, now is a good time to get one. The PPR practice tests must be taken on or before November 30th.

*****For those students who pass the practice PPR, and take and pass the TExES PPR K-12 Test, you will receive an A in the class provided you have met all the other class requirements.
