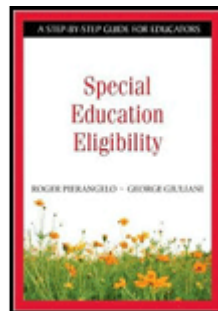

#### Course Description:

A survey of exceptional children involving categorical identification, learning characteristics, instructional intervention, and adjustment needs.
