### 3) Executive Reports

- a) Before officially combining staff councils across campuses, Grace Ibarra will email International campus staff to discuss if there is a unified desire to join together.
- b) Per discussion with Staff Council Officers, Bonnie Albright acknowledges that many budgets are not loaded.

## 4) Committee Reports

- a) Bylaws committee update:
  - i) Staff Council Bylaws currently in a rough draft of revisions
  - ii) Pending international campuses inclusion
  - iii) Possible new name for Staff Council: Staff Senate
  - iv) Clarification re chair and vice chair officer positions
  - v) Administrators may attend meetings by invitation only
  - vi) Changes to allocation. Currently have 12 reps; proposed to have 15
  - vii) Would have 5 members at large (not elected, just people who are passionate about participating)
  - viii) Change term limit for Representatives: change to 2 years (eliminate staggered). Officer term limits stay the same
  - ix) Changes to position duties to reflect actuality
  - x) Use Robert's Rules of Order as necessary, but allow for a more relaxed meeting structure

- xi) Last portion of meetings will be Open Forum as time allows
- b) Katy Williams reported that the President no longer hosts All-Staff Meetings, only hosts Directors Meetings. All-Staff Meetings will likely occur twice per year unless we request more.

# 5) Old Business

- a) Angela McGuyer reported her findings on parental leave bill SB 222 and why it does not apply to higher ed staff. Not clear why. But, if apply for and eligible for FMLA leave, will have the job secured and be paid as long as have the available leave—for up to 12 weeks. Compared to Tarleton: they have a section called "other leave provisions." Taylor reported that the original bill did not exclude Higher Ed staff, and a rep from East Texas' committee added that exclusion in.
