Film Analysis: 10%

You will select and view a film in relation to at-risk youth and characteristics associated with them. Every time that you use terminology/phrases from assignments and your book, you are to highlight them in yellow. This will help you focus on issues related to at-risk youth. Your role will not be to critique the films. Rather, you will analyze situations in the film depicting demonstrations of youth at-risk and all of the surrounding factors such as family, mood disorders, stress, etc. This paper should be at least five complete double-spaced typed pages in length. Email this assignment to me, due Tuesday, June 25th. This film analysis is worth 10%.
