### **Grading Policy/Course Measurements**

You should expect to spend as much time in this class as you would for a face-to-face class. Face-to-face classes meet for three hours a week, and that amount of time does not include the time devoted to outside assignments. You should expect to spend six to nine hours per week, maybe more, working on assignments for this course.

**Discussions will be posted in Blackboard** on Friday at 4p. Your initial response to the discussion question will be due, for full credit, the following Monday by 1130p. Replies to other students are due by Thursday at 1130pm. 5 Points will be deducted each day after Monday for late initial post. For Discussion you will be expected to comment on the initial response of three other student posts. 5 points will be deducted for each failure to respond. 0 credits will be given for anything turned in after Thursday. Do not wait until the last minute to submit your responses. Sometimes Blackboard is down due to regular maintenance or other issue, which means it may not be available during the time you want it to be. In addition, your computer or internet connection may not be working when you need them to be. Give yourself plenty of time to submit your assignments.

There will be eight (8) discussion learning questions. Discussions will be in Discussions Boxes. The discussions will each be worth 40 points. For the eight (8) discussions your initial answer will be at least 400 words and include two proper citations. Students are required to comment on the initial response of three fellow students for each of the eight (8) discussions. Responses are required to be 250 words with at least one citation. There is a deduction of five points for each missed response and responses that are not complete. Follow up discussion is encouraged. All assignments will be graded on grammar, spelling,

content, completeness and participation. Failure to answer and reply to a test or discussions will result in a 0 assigned for that particular assignment.

There will also be a term paper on National Security and the Constitution that will act as your final exam. This paper will be between 17 and 20 pages at a minimum. Proper APA Seven format is required, including citations and reference section. You will provide your research question (topic) to me by week 4. The paper itself will be due by Friday of Week 15. The paper will be worth 200 points. You will be provided specifics on how the paper will be formatted and grading criteria.
