#### **Course Catalog Description:**

Course will provide a conceptual framework of the legal system with regards to natural resources. Examines the existing policies and laws regulating wildlife, water, and land use. Reviews the roles and philosophies of various regulating and policy-making agencies including federal, state, and private organizations.

#### **Course Objectives:**

On completion of this course, students will understand environmental law including: 1) historical and present philosophies of state, federal, and private administrative organizations that manage or influence natural resource policy; 2) laws and regulations on pollution of air, water, and land; 3) the public trust doctrine and the protection of wetlands and endangered species; 4) renewable energy; and 5) NEPA and environmental impact statements.

#### **Required Textbook:**

# Weekly Course Activities:

Under the **COURSE CONTENT** menu in Blackboard, find required activities for each week of the course. Activities include required reading, reviewing, and/or viewing and responding to prompts, then engaging in conversation in the **Discussion Board**.

The class is structured into weekly time periods that begin on Monday and end on Sunday. All assignments are due by Sunday. In case of a technical issue with Blackboard on the weekend, you will be given a grace period until Monday at noon to submit assignments. **NO LATE ASSIGNMENTS WILL BE ACCEPTED.** 

Each activity will be graded based upon the relevance, depth of knowledge, and unique contribution that it made to the discussion and/or course. Each Course Activity is worth 25 points. You are graded on rubrics which are accessible in **My Grades** on Blackboard under **COURSE INFORMATION**. For example, in order to achieve maximum points for *Timely and Complete* Participation (20% of each 25 points possible), for each Discussion Board activity, make your first original post (by midnight Thursday), and minimally comment on at least two (2) posts by other students (by midnight Sunday).

## **Discussion Board Facilitation:**

An additional course activity requires a student to facilitate the discussion on the Discussion Board each week. During Week 1's Activities, each student will select two weeks to act as facilitator. More instructions and information about grading are on Blackboard under **Activity Info – Discussion Board Facilitation**.

# Syllabus Quiz:

Before the **COURSE CONTENT** can be accessed (including content for Week 1), students must review the **Start Here module content** and complete the **Syllabus Quiz**. The Start Here module content is available under **COURSE CONTENT** on Blackboard.

## Exams:

There are three (3) short answer and/or essay question exams throughout the course: Week 4, Week 9, and Week 15. Exams cover the textbook and other readings assigned in class. Exams are given online in Blackboard and worth 100 points each, 10% each of your total grade. Review for exams by answering the questions at the end of each chapter of the textbook. A rubric will be made available before Exam 1.

You will receive feedback on each graded assignment in the **My Grades** area of Blackboard. Grading percentage breakdowns are below. Rubrics for assignments are available in **My Grades** as well.
