# COURSE SYLLABUS CRIMINAL JUSTICE 4302 – CONSTITUTIONAL LAW SUL ROSS STATE UNIVERSITY – RIO GRANDE COLLEGE SPRING - 2023

**COURSE DESCRIPTION:** This course will assist the student in mastering the crucial aspects of substantive law and procedural due process in the enforcement of criminal law. The course seeks to provide a strong foundation for understanding the purpose of law and the rule of law to maintain a civilized and stable society. The course will also explore civil liberties of the constitution and discuss how the related civil liabilities influence the criminal justice system.

#### By the end of this course, the objectives are to:

- 1) To familiarize the student with the fundamentals premises and design of the constitutional system and government of the United States.
- 2) To expose the student to the guiding principles and applicable doctrines of select subfields of constitutional law.
- 3) To cultivate the student's ability to identify and discuss pertinent constitutional issues.
- 4) To provide the student with the intellectual skills necessary to properly analyze and conceptualize constitutional issues.
- 5) To foster an informed perspective on the nature and limits of constitutional judicial decision-making

#### **COURSE NOTES**

Being that this is a web-based course, the course will be dependent on the class blackboard page. All course communication and instruction will take place through blackboard and the student's registered Sul Ross email address. Assignments/instruction will be posted on a weekly basis, and unless instructed otherwise, all weekly assignments will be submitted by the specified due date utilizing the appropriate web-based assets on the class blackboard site. #### **Grading Policy**

The final grades for the course will be determined based on the compilation of the following components:

- "Weekly" assignments/quizzes over the life of the course, there will be numerous assignment/quiz grades, which will be averaged together and constitute 50% of your final grade
- Midterm Exam to be held on Wednesday, March 22, 2023 from 6:00 p.m.
   to 9:00 p.m. will constitute 25% of your final grade
- Final Exam to be held on Tuesday, May 16, 2023 from 6:00 p.m. to
   9:00 p.m. (25% of final grade)

  important it is to complete ALL of the assignments and the exams. Do not
  expect to do well in this course otherwise.

- Final grades will be determined by obtaining the average of the weekly assignments/quiz grades and multiplying by .50, and multiplying the Midterm and Final exam grades each by .25. The three percentages are then added together to determine the final numerical grade.
