Course Description:

This course will address important matters pertaining to contemporary issues in Bioethics. We will focus on the history of Bioethics with attention to how particular religious and philosophical themes inform issues of human suffering and death. Our textbook will provide challenging readings that enable us to discuss areas of concern classified in the field of Bioethics: in vitro fertilization, abortion, genetic engineering, euthanasia, assisted suicide, and (perspectives on) death and dying.

Course Objectives- upon completion of the course students will be able:

- 1. To communicate about the various topics that shape the discipline of Bioethics;
- 2. Think critically about the foundations of the Western Philosophical Traditions;
- 3. Think critically about their own philosophical ideologies with regard to Bioethics;
- 4. Appreciate and respect the views of their classmates;
- 5. Through group inquiry participate in a dialogue that started many years ago;
- 6. Work on reaching a level of logical precision in expressing and writing their ideas.
