## **COURSE DESCRIPTION**

This course is intended to deepen the students' knowledge about the topics and issues related to White-Collar Crime. More specifically, the course provides extensive information about the issues related to the phenomena of white-collar crime. During the course, the students will gain knowledge about the definition, types, concepts, theories, law enforcement, judicial, and correctional efforts, countering strategies, and other issues relating to white-collar crime.

## **COURSE LEARNING OBJECTIVES**

This course is designed to provide knowledge about various topics related to white-collar crime. Upon successful completion of this course, you will be able to:

- **LO1-** Understand the evolving definition and characteristics of white-collar crime. The extent and consequences of white-collar crime
- **LO2-** Learn and understand the different types of white-collar crimes in various businesses (retail system, entertainment business, insurance systems, health care systems, and etc.)
- **LO3-** Learn, examine and discuss the different social and individual theoretical approaches explaining white-collar crimes.
- **LO4-** Learn and understand the relationship between white-collar crimes and cybercrime.
- **LO5-** Learn and understand the relationship between white-collar crimes and the corporate system.
- **LO6-** Learn and understand the relationship between white-collar crimes and environmental crime.
- **LO7-** Learn and understand the national and global law enforcement institutions for policing white-collar crime.
- **LO8-** Learn and understand the judicial procedure and proceeding of white-collar crime.

## **MARKETABLE SKILLS:**

# **CLASS ATTENDANCE/PARTICIPATION:**

## **REACTION PAPERS (10 POINTS EACH)**

You will write a reaction paper every week. Each paper must be 1 page and 1.5-spaced in 12-point Times New Roman font. Reaction papers will be related to the reading of the week. When there is more than one reading assignment, then the students **SHOULD READ ALL REQUIRED READINGS BUT WRITE REACTION PAPER ON ONE OF THEM**. A reaction paper is not a summary; rather, it should include your perspective, ideas, and critique of the reading. The due dates for the reaction papers will be Sunday at 11:00 pm each week.

# WEEKLY QUIZZES (10 POINTS EACH)

You will take a quiz every week to measure the knowledge of the week's required readings. The questions will be posted Friday at 1:00 pm and due date will be Sunday at 11:00 pm every week.

## MIDTERM EXAM (100 POINT)

For your midterm exam, you will prepare an annotated bibliography of 10-12 sources as part of your final paper literature. Use scholarly, scientific, peer-reviewed articles. Credit will not be given for articles that are not from scholarly journals (The only exemption will be government/expert reports). Don't use web articles unless they are copies from a journal article, no magazines such as NYT, Time or Newsweek, etc. Scholarly research articles use the scientific method to examine an issue

While you are preparing your bibliography, try to answer these questions about the source you are reading. These answers/annotations should include one or more sentences.

- 1. Name the author(s)
- 2. What was the purpose of the author in writing the piece?
- 3. What are the author's major assertions or findings?
- 4. How does the author support these findings?
- 5. Compare or contrast this work with another you have cited
- 6. Discuss how this work explains your selected topic
- 7. Information about the research methods used in the source
- 8. Above all write an intro paragraph about your topic and why do you think it is important

#### **Format Rules:**

**1.** You will prepare your bibliography by using the American Psychological Association (APA) for showing your citations for these resources.

# FINAL/RESEARCH PAPER (200 POINTS)

Since this course is specifically designed on WHITE COLLAR CRIMES, you will write a final paper on any elements of white-collar crime (policy, causes, theoretical explanations, impacts, extend, types, areas, techniques, detection, investigation, sentencing, landmark cases, etc.). Regarding formatting, a sample paper will be posted on the blackboard.

The paper should include <u>AT LEAST TEN</u> <u>SCHOLARLY CITATIONS</u> (not website articles, Wikipedia, news agencies, magazines, and etc.), be ten to fifteen pages long (not including cover page and list of references), and typed double-spaced in 12-point Times New Roman font. Be sure to follow APA formatting and citation guidelines. <u>FINAL PAPER SUBMISSION WILL BE IN THREE SUBSEQUENT STEPS: 1- Introduction of Topic, 2- Annotated Bibliography, and 3- Final Submission.
