Course Description: A continuation of MUS 2116, designed as the aural skills complement to MUS 3341 (Music Theory IV). Emphasis will be placed on the solfège singing of major and minor melodies at sight, rhythmic reading in simple and compound meters, and melodic, rhythmic, and harmonic dictation.

Rogers, Nancy and Robert Ottman. *Music for Sight Singing*, 10th edition. Boston: Pearson, 2019.

Manuscript paper and pencil (required for every session)

Objectives:

This course is designed to give students increased skills in musicianship, with particular emphasis on sight singing and dictation.

Specific skills to be acquired/strengthened include:

- Aural recognition of any harmonic interval within the octave
- Singing and identification in any register of scale degrees in major or minor keys
- Melodic dictation of non-modulating melodies, including 7th-chord arpeggiations
- Reading of rhythms in simple and compound meters, including subdivisions, triplets, duplets, and syncopation, using rhythmic syllables while conducting
- Aural recognition of seventh chord types, including inversion
- Harmonic dictation of progressions, including all diatonic triads, seventh chords, and non-chord tones
- Dictation of two-voice 2:1 counterpoint

Student Learning Outcomes for Music Majors:

SLO 1: All students will demonstrate the ability to integrate appropriate musical expression into performance.

SLO 2: All students will demonstrate the ability to research and prepare appropriate program notes.

SLO 3: All students will demonstrate the ability to evaluate and critique a musical performance.

Attendance:

Regular, punctual attendance is essential if the educational objectives of this course are to be achieved, particularly given its interactive nature. Attendance will be taken at the beginning of every class.

In accordance with the *Sul Ross State University Student Handbook*, any student who accumulates more than nine (9) absences may be dropped from a course at the faculty member's discretion.

Success in this course is closely linked to practice outside of class. A significant portion of homework for the course will consist of melodies or rhythms to be prepared independently and performed and graded in class.

Grading guidelines for sight-singing and dictation:

- A+: Correct pitches, rhythm, and conducting, performed confidently and musically
- A: Correct pitches, rhythm, and conducting
- A-: Minor errors in one or two areas
- B+: Minor errors in three areas or 1-2 obvious rhythm errors; stopping and continuing
- B: 2-3 serious pitch errors or serious rhythmic errors; stopping and beginning again
- B-: 3-4 serious pitch errors and/or many rhythmic errors
- C: Starting over more than once; additional pitch and rhythm errors; failure to conduct accurately
- D: Numerous errors in all areas; lack of orientation to key center; poor preparation
- F: Numerous errors in all areas; lack of concentration
