## **Course Description**

This course is a scientific study of human society, including ways in which social groups, social institutions, and individuals affect each other. Causes of social stability and social change are explored through various theoretical perspectives, key concepts, and related research methods of sociology. Analysis of social issues in their institutional context may include topics such as social stratification, gender, race/ethnicity, and deviance.

#### **Course Learning Objectives**

Upon Completion of this course, you will:

Compare and contrast the basic theoretical perspectives of sociology.

- ➤ Identify the various methodological approaches to the collection and analysis of data in sociology.
- Describe key concepts in sociology.
- Describe the empirical findings of various subfields of sociology.
- Explain the complex links between individual experiences and broader institutional forces.
- Develop critical thinking skills to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information.
- > Develop empirical and quantitative skills to include the manipulation and analysis of numerical data or observable facts resulting in informed conclusion

This course is also a part of the core curriculum. Students in core curriculum courses are expected to excel in certain skills. The Texas Higher Education Coordinating Board (THECB) requires each Fall and Spring Core Course Instructor to integrate assigned core objectives into their courses each year. There are two skills to be assessed for the 2023-2024 academic year for ALL Core Courses and they are Critical Thinking and Communication.

- Critical Thinking Skill: Students will develop critical thinking skills to include creative thinking, innovation, inquiry, analysis, evaluation, and synthesis of information.
- Communication Skill: Students will develop communication skills to include effective development, interpretation, and expression of ideas through written, oral, and visual communication.

## **Attendance Policy**

Students are expected to respect their classmates' and instructors' privacy and the work or comments they produce. All assignments you submit or tests you take must be your own work unless you have been requested that you work in groups. You may not submit work that is plagiarized or violates copyright laws. It is also your responsibility to respect copyright protection of licensed computer software. When you are taking a distance education course from a remote site, please remember that you are "guests" on the remote site campus. The facilities, equipment, staff, and materials at that site are neither the property nor employees of Sul Ross State University. Please treat the site respectfully and be responsible in caring for the site that we have been allowed to use.

Absence policies in effect for on-campus, traditional classroom instruction courses also apply to students enrolled in distance education courses, including Web-based and ITV courses. The University allows a maximum of 20% absences in a course before an instructor may drop a student for excessive absences with a grade of "F". In Web courses, this policy is interpreted as not participating for more than 3 weeks in a long semester or 1 week in a summer session. Any student dropped for non-participation will receive an "F" in the course dropped. Inactivity may include the following:

- Not logging on to the course
- Not submitting assignments
- Not participating in scheduled activities
- Not communicating with the instructor by phone or email, and/or
- Not following the instructor's participation guidelines stated in the syllabus.

All students taking distance learning classes are <u>responsible for checking their Sul Ross email account</u> regularly for notices from the School and from their instructors. A student's Sul Ross email address is added to Blackboard when a student registers, so when instructors email students through Blackboard, the message is sent to the student's Sul Ross email account. Email accounts are automatically set up when a student registers. In order to use your SRSU email account, you will need to log in to the email system. The information you need in order to log in is a username and a password.

#### **Class Participation Policy**

Students are encouraged to attend the class, ask questions and express opinions; however, talking among students and disruptive behavior will not be tolerated. You may bring beverages to class with you, but not food. Reading outside materials such as newspapers or other course work is not permitted during class time. Students should be prepared to engage in discussion over the assigned readings, and for possible pop quizzes. Electronic devices are never allowed to use in class in a way to distract the instructor and other students. Keep your mobile phone in silent mode, otherwise switch it off. There will be one general rule in class which applies to all situations. This is also called "golden rule". TREAT OTHERS AS YOU WOULD LIKE TO BE TREATED.

#### **Course Assessment**

- 1 Weekly Quizzes (10 Points Each): You will take a quiz every week to measure your knowledge of the week's required readings. The questions will be drawn from the readings and the supplemental materials posted on the Blackboard. Weekly quizzes will be available until Sunday at 11:59 PM of that week.
- <u>2 Midterm Exam (100 points):</u> There will be a midterm exam which will cover the assigned chapters and other relevant material covered in the course up to the date of the examination. The midterm exam is worth 100 points. The midterm exam will have multiple-choice and/or true-false questions. No makeup test will be given, unless an uncontrollable emergency or illness arises (written proof required).
- <u>3 Final Exam (100 points):</u> The Final Exam is comprehensive; thus, it will test students on all the topics covered during the course. The Final exam is worth 100 points. Final exam will have multiple-choice and/or true-false questions. No make-up test will be given, unless an uncontrollable emergency or illness arises (written proof required).
- **4 Final Paper (100 Points):** You will write a final paper on any of the subjects covered in this course. You will <u>submit a written proposal by the end of the 4<sup>th</sup> week</u> outlining your plan and intended subject. You will then continue writing your paper after my approval.

Each paper must have a "Title Page", "Table of Contents", "Abstract", "Body of the Paper", and "References". Only count the "Body of the paper" towards your minimum page limit.

The paper should;

- a) be 5+ pages (this is just the "Body of the Paper" excluding all other pages),
- b) be typed, double-spaced, 1 inch margins, 12-point Calibri font,
- c) include <u>at least three scholarly citations</u> other than the ones we covered in the class (not website articles, wikipedia, news agencies, magazines, and etc.),
- d) be written according to APA formatting and citation style.

A plagiarism detection software (SafeAssign) is used in this course. SafeAssign will detect and report all instances of plagiarism including where the student copied and pasted directly from a source. Students will receive a grade of "0" in these instances, and possibly fail the course. Your weekly reaction papers and final paper will be submitted through SafeAssign.

#### **Academic Integrity**

#### **Social Science BA Programs Marketable Skills**

The Texas Higher Education Coordinating Board (THECB) sets statewide goals through the 60x30TX initiative. The THECB plan includes four major goals: 60×30: Educated Population, Completion, Marketable skills, and Student debt. The 60x30TX plan was designed to tie together all four student-centered goals. 60x30, which measures the educated population in Texas, is the overarching goal at the center of the plan and calls for 60 percent of 25- to 34-year-olds in Texas to hold a credential or degree by 2030. The 60x30 goal is supported by the other three goals (completion, marketable skills, student debt) that will get Texas to 60 percent by 2030.

By 2030, all graduates from Texas public institutions of higher education will have completed programs with identified marketable skills. Students who can effectively market their skills to potential employers can secure employment that pays competitively. Marketable skills include interpersonal, cognitive, and applied skill areas, are valued by employers, and are primary or complementary to a major. Marketable skills are acquired by students through education, including curricular, co-curricular, and extracurricular activities. Marketable skills are often called "employability skills" in other countries, or "transferable skills" here in the states. They include both technical and soft skills. The marketable skills of Social Science BA Programs are listed as follows:

- 1) Students can identify useful resources from a pool of data.
- 2) Students can select and organize data in a relevant manner.
- 3) Students can make written presentations to various audiences.
- 4) Students can utilize data to persuade various audiences.
- 5) Students can utilize data to generate and strengthen ideas.
- 6) Students can decipher stances adopted by various individuals.
- 7) Students can meet deadlines in a successful manner.
- 8) Students can discharge responsibilities in an adequate manner.
- 9) Students can manage the absorption of data.

## **Other Course Expectations**

- Remember that this is a college course, therefore, college-level work will be expected which includes proper APA format, proper grammar, sentence structure, and organizational structure.
