COURSE DESCRIPTION

No text is required. CLASS DESCRIPTION: Disc Golf (1-2). This course introduces the fundamentals of disc golf. Emphasis is placed on basic throwing techniques putting distance driving scoring and single and doubles play. Tournament and match play formats will also be introduced. NOTE: Basic equipment will be provided. Open to all levels.

PURPOSE OF COURSE

The purpose of this class is to "encourage students to find meaningful activities that will lead to life-long leisure pursuits". This course requires no previous experience of playing Disc Golf. Learning the basics of the sport while reaping the benefits of learning a new activity to do during leisure time. Class will meet in the Graves-Pierce lobby downstairs. From there we will begin with class discussions, and gather required equipment for that day's activity. We will utilize a GroupMe link along with Blackboard announcements for any changes to class times or meeting locations.

MARKETABLE SKILLS- The following marketable skills are met in this course:

- **Collaboration** – students will interact with one another through a multitude of class discussions and activities
- **Communication** – students will communicate on areas that need improvement
- **Teamwork** – Students will learn to work as a team through playing the sport

COURSE OBJECTIVES: Students will be able to:

By the end of the course, the successful student should be able to: 1. Identify basic rules of disc golf. 2. Demonstrate correct fundamentals. 3. Demonstrate their knowledge of the various discs and when/how to use each. 4. Gain basic knowledge that will allow the students to participate in the sport and also to share the sport with others.
