### **Course Description:**

This course is designed to prepare students for the teaching of undergraduate music theory. Representative texts and writings in the field will be studied, with particular emphasis on acquisition of recent learning theories. Strategies for incorporating key components of an undergraduate theory course will be examined, including aspects of harmony, voice leading, counterpoint, figured bass, rhythm, computer-assisted instruction, post-tonal theory, and keyboard skills.

### **Student Learning Objectives:**

At the end of this course, the student will be able to:

1. Identify the components of an undergraduate music theory sequence
2. Develop an understanding of learning styles
3. Acquire a knowledge of different approaches to the study of written theory
4. Discuss the relative merits of different teaching strategies associated with each component of an undergraduate theory sequence
5. Identify principal textbooks for a music theory sequence and discuss the teaching strategies and philosophies upon which they are based
6. Develop the conceptual and practical knowledge to design a syllabus for a 4-semester music theory sequence

### **Grading:**

The final grade for this course will be based on teaching internships and tutoring (30%), 3 short papers (30%), annotated bibliographies of relevant materials (20%), and assigned reading summaries (20%).

Summaries of assigned readings should be kept and collected in chronological order in a notebook. The complete notebook will be submitted for evaluation at the end of the course.
