## **COURSE DESCRIPTION:**

Wildlife Law Enforcement is a course that is designed to give the student a basic understanding of the history, purpose, and processes of wildlife law in the United States. During this course, students will examine where the need for wildlife criminal law originated, how it has developed over time, the different roles state and federal agencies play in wildlife law, and the current issues faced in the world of wildlife law enforcement.

## **LEARNING OBJECTIVES:**

Upon successful completion of the course the student will be able to:

LO1 – Describe the North American Model of Wildlife Conservation

LO2 – Explain the need for wildlife law enforcement

LO3 – List the federal acts that helped shape wildlife law enforcement

LO4 – Describe the roles that state and federal wildlife law enforcement officers have

LO5 – List the major current issues that are faced by wildlife law enforcement officers

LO6 – Describe the future challenges that may hinder wildlife law enforcement efforts

## MARKETABLE SKILLS

MS 8 – Enforcement techniques utilized by those who enforce wildlife law

### **CLASS ASSIGNMENTS AND PROJECTS:**

**Discussion Posts (10 Points Each)** – For each discussion post, you will provide a minimum **250-word response** to the question assigned each week. **You must also respond to at least 1 of your classmate's posts.** Please post your initial response by each Thursday so there is ample time for responses. The due date for initial posts and responses is Sunday at 11:59 pm on the assigned week.

<u>Quizzes (10 Points Each)</u> – The quizzes will be **20 multiple choice and true/false questions** over the required reading materials. The due date will be Sunday 11:59 pm of the assigned week.

**Opinion Papers (50 Points Each)** – Throughout the course, there will be four opinion papers due. For these papers, you will read the assigned article and write an opinion paper about its contents. These are not meant to be summaries, but rather your own thoughts on the material. The papers will be a minimum of **2 pages (not including cover and reference pages), double spaced, and size 12 Times New Roman font.** At least **2 sources** are required for each paper, one source will be the assigned article, the additional source(s) will be articles you find related to the assigned material and used to support your viewpoint on the topic.

<u>Midterm Test (100 Points)</u> – The midterm will be a **50-question multiple choice and true/false test** over all material covered in the first half of the course.

**Final Paper (200 Points)** – The final paper will be a research paper over your choice of a provided list of wildlife laws. For this paper, you will select a law and review its history (when and why it was adopted), outline the law and its purpose in wildlife conservation, give examples of any notable criminal cases involving this law, and give your opinion on any shortcomings this law has. You should review the law and any material associated with it and discuss its restrictiveness, its applicability with conservation efforts, methods of enforcement, and your personal opinion on whether the law should be changed in any way, or even be repealed. I will provide the class with a list of laws, both federal and state, that may be used for your final paper after midterms. The requirements are that the paper is in APA format, includes a minimum of 3 academic sources, 5 total sources and has a cover page, abstract, table of contents, body, and reference page. The body of the paper should be 7 pages minimum (not including cover, abstract, table of contents, and reference page). Use 12 point, Times New Roman font, double-spaced with normal margins. The paper will be submitted to SafeAssign to detect any plagiarism. Please make sure to use proper spelling, punctuation, paragraph formatting, and in-text citations.

There will be opportunities for extra credit for this course. Please monitor your email and the course announcements for information when extra credit opportunities arise. Extra credit points will be added directly to your final grade score.
