This course is intended to introduce you to the steps of criminal investigation. More specifically, the course provides information about the definition, history, and types of criminal investigation process. Role of documentation, definition and types of evidences, the laws related to criminal investigations. Students will also get information about evidence collection from crime scene, role of interrogations and confessions in criminal investigations. Moreover, investigation methods for certain crimes such as, cybercrimes, frauds, homicides, sex crimes, robbery, burglary will be covered during the course.

COURSE LEARNING OBJECTIVES

This course is designed to provide knowledge about various topics related to American Criminal Justice system. Upon successful completion of this course, you will be able to:

LO1- Define the criminal investigation process, criminal evidence, and forensic science

LO2- Explain the role of criminal investigations in the criminal justice process.

LO3- Define the basic distinctions of criminal evidence, including the distinctions between judicial evidence and extrajudicial evidence and those between exculpatory evidence and inculpatory evidence.

LO4- Explain the various types of evidence, including direct, circumstantial, testimonial, real, documentary, and demonstrative

LO5- Discuss the three roles or functions of physical evidence in the criminal investigation process and define class characteristic and individual characteristic forensic evidence.

LO6- Discuss other types of forensic evidence, including fingerprints, bite marks, shoeprints, firearms, and drugs.

LO7- Identify how criminal profiles are constructed, explain the meaning of various perpetrator actions, and discuss the effectiveness of criminal profiles

LO8- Identify and evaluate the legal, technical, and practical issues related to the collection and use of digital evidence in criminal investigations

LO9- Learn and understand the ways social media can be used by investigators

LO10- Understand and identify various methods for different types of offenses such as, cybercrimes, frauds, homicides, sex crimes, robbery, burglary

MARKETABLE SKILLS:

CLASS ATTENDANCE/PARTICIPATION:

Given that this is a fully online course; you cannot attend class in a traditional sense. Weekly reaction papers and quizzes are a required part of class participation.

REACTION PAPERS (10 POINTS EACH)

You will write a reaction paper every week. Each paper must be 1 page and 1.5-spaced in 12-point Times New Roman font. Reaction papers will be related to the reading of the week. When there is more than one reading assignment, then the students <u>SHOULD READ ALL REQUIRED</u> <u>READINGS BUT WRITE REACTION PAPER ON ONE OF THEM</u>. A reaction paper is not a summary; rather, it should include your perspective, ideas, and critique about the reading. The due dates for the reaction papers will be Sunday 11:00 pm each week.

WEEKLY QUIZZES (10 POINTS EACH)

You will take a quiz for every week to measure the knowledge of the week's required readings. The questions will be posted Friday 1:00 pm and due date will be Sunday 11:00 pm every week.

MIDTERM AND FINAL EXAMS (200 POINTS EACH)

There will be 2 major exams throughout the semester, with questions drawn from the readings and the supplemental materials posted by the professor. These 2 exams will be worth 200 points each. There will be no makeup exams.
