# **Course Description**

Independent study or a research on a topic with supervision by a faculty member. This particular course is an internship independent study in which students will perform assigned tasks for a particular College within the University. Students will reflect upon their real-world experience, submit samples of professional communication and project deliverables, and along with their supervisor, complete a performance evaluation. Students will leave the course better prepared to perform duties that will be expected of them in their chosen professions.

#### Timesheets (10% of Final Grade):

You should post your weekly timesheet which shows the hours you worked each week.

#### Reflective Journal (30% of Final Grade)

Each week you will submit a reflective journal which will allow you to think critically, applying the knowledge you have gained to real-world practice. Each entry should be 1-2 pages, double-spaced, and organized by date. Each entry should contain the following:

- Weekly Overview
- Learning and Application
- Challenges and Solutions
- Growth and Development
- Connections

See your class for how each journal will be evaluated.

#### **Project Deliverables (15% of Final Grade)**

As instructed by your professor, you will submit project deliverables you have created during the course of your internship.

#### **Examples of Professional Communication (15% of Final Grade)**

As instructed by your professor, you will submit examples of professional communication including but not limited to: correspondence, meeting minutes, presentations, etc.

# Review of Supervisor Evaluation and Final Reflection (30% of Final Grade)

Similar to the real world, your supervisor will be completing an evaluation of your work performance for the semester. You will self-score your performance, your supervisor will score your performance, and the two of you will meet to discuss the results. In addition, you will submit a final reflection that describes your key takeaways and how the internship has prepared you for your career.

## **Course Schedule**

Your course schedule will be determined by your internship supervisor. You will submit your timesheets and reflective journals weekly, your examples of professional communication and project deliverables during week 15 of the semester, and your supervisor evaluation and final reflection during finals week.
