**Course Description:**

In this course we will cover the fundamentals of managerial accounting. We will cover accounting concepts and their application in transaction analysis and financial statement

preparation; analysis of financial statements; and asset and equity accounting in proprietorships, partnerships, and corporations. We will expand on the accounting concepts and applications learned in financial accounting by looking at cost behaviors and management decisions based on costs and financial statements.

This is an online scheduled course that will take place over the normal course of the Fall 2025 semester. The course will have live lectures on Monday and Wednesday's from 11:00 a.m. to 12:15 p.m. As a synchronous student, you will login to the course using **Microsoft Teams**, not Blackboard Collaborate. You will receive a link to all scheduled courses. See the "Attendance" section of the syllabus. We will cover 11 chapters that will usually correspond with one week of the course. However, there are certain weeks where more or less time is allotted. See the course schedule for all due dates. For each module, there will be assignments to be completed through McGraw Hill's Connect program, which is linked to the required course textbook. In addition, there will be four normal Comprehension Opportunities (exams) throughout the course that will test the knowledge that you have gained. There will also be at least four discussions via Blackboard throughout the course. The discussions may also be used as a tool to learn more about your fellow students and your professor. There may be additional discussions that are not scheduled at this time. The non-scheduled discussions will be announced to you a week before they are due and they will be used to portray your understanding of the tools we are learning about and how they are important to our course material. We will also work on a financial statement analysis project for this course using skills learned throughout the course.

### **Classroom Etiquette**

We will be participating in discussions and interacting with each other throughout this course. It is important for all students to be respectful and kind to one another, regardless of any differences. The course requires respect be shown at all times.

### **Attendance**

This course is set up to be an online course with scheduled meetings. We will meet virtually for the scheduled classes on Mondays and Wednesdays from 11:00 a.m. to 12:15 p.m. You will

receive a Microsoft Teams link from your professor to access the course at scheduled times. You are responsible for attendance to the course, which is mandatory. Your attendance will be based on presence, *as well as interaction in the course*. If you will be out for a school function, it is your responsibility to communicate this with your professor BEFORE the absence. You will be responsible for the lectures and information given to you during the class time. Therefore, attendance ***is mandatory*** and will be a part of your grade. You will need to participate in class and show yourself on camera for full attendance credit.

The class is a 75-minute class. If you arrive to class more than 25 minutes late, you will be counted absent. I would still suggest that you show up, so that you are not behind in the lectures. However, it is important to be punctual and in class on time. Announcements and reminders will likely be given at the beginning of the class. In addition, missing too much of a lecture could set you behind.

PowerPoint lectures and other information will be posted on Blackboard for your convenience, as well. You are responsible for viewing/reading class materials that are posted on Blackboard. You are responsible for the topics and the due dates.

### **Academic Honesty Policy**

The University expects all students to engage in all academic pursuits in a manner beyond reproach and to maintain complete honesty and integrity in academic experiences both in and out of the classroom. The University may initiate disciplinary proceedings against a student accused of any form of academic dishonesty, including but not limited to, cheating on an examination or other academic work, plagiarism, collusion, and the abuse of resource materials.

Academic Dishonesty includes:

1. Copying from another student's test paper, laboratory report, other report, or computer files, data listings, and/or programs, or allowing another student to copy from same.
2. Using, during a test, materials not authorized by the person giving the test.
3. Collaborating, without authorization, with another person during an examination or in preparing academic work.
4. Knowingly, and without authorization, using, buying, selling, stealing, transporting, soliciting, copying, or possessing, in whole or in part, the contents of a non-administered test.
5. Substituting for another student; permitting any other person, or otherwise assisting any other person to substitute for oneself or for another student in the taking of an examination or test or the preparation of academic work to be submitted for academic credit.
6. Bribing another person to obtain a non-administered test or information about a non-administered test.
7. Purchasing or otherwise acquiring and submitting as one's own work any research paper or other writing assignment prepared by an individual or firm. This section

does not apply to the typing of a rough and/or final version of an assignment by a professional typist.

8. “Plagiarism” means the appropriation and the unacknowledged incorporation of another’s work or idea in one’s own written work offered for credit.
9. “Collusion” means the unauthorized collaboration with another person in preparing written work offered for credit.
10. “Abuse of research materials” means the mutilation, destruction, concealment, theft, or alteration of materials provided to assist students in the mastery of course materials.
11. “Academic work” means the preparation of an essay, dissertation, thesis, report, problem, assignment, or other project that the student submits as a course requirement or for a grade.
12. “Falsification of Data” means the representation, claim, or use of research, data, statistics, records, files, results, or information that is falsified, fabricated, fraudulently altered, or otherwise misappropriated or misrepresented.

All academic dishonesty cases may be first considered and reviewed by the faculty member. If the faculty member believes that an academic penalty is necessary, he/she may assign a penalty, but must notify the student of his/her right to appeal to the department chair, the College Dean, and eventually to the Graduate Dean before the imposition of the penalty. At each step in the process, the student shall be entitled to written notice of the offense and/or the administrative decision, an opportunity to respond, and an impartial disposition as to the merits of his/her case. The decision of the Graduate Dean shall be final.

In the case of flagrant or repeated violations, the Graduate Dean may refer the matter to the Dean of Students for further disciplinary action. No disciplinary action shall become effective against the student until the student has received procedural due process except as provided under Interim Disciplinary Action.

### **Academic Integrity**

Students in this class are expected to demonstrate scholarly behavior and academic honesty in the use of intellectual property. Students should submit work that is their own and avoid the temptation to engage in behaviors that violate academic integrity, such as turning in work as original that was used in whole or part for another course and/or professor; turning in another person’s work as one’s own; copying from professional works or internet sites without citation; collaborating on a course assignment, examination, or quiz when collaboration is forbidden. Students should also avoid using open AI sources *unless permission is expressly given* for an assignment or course. Violations of academic integrity can result in failing assignments, failing a class, and/or more serious university consequences. These behaviors also erode the value of college degrees and higher education overall.

### **Use of Generative AI in Course**

The use of generative AI is encouraged with certain tasks and with attribution: You can choose to use AI tools to help brainstorm assignments or projects or to revise existing work you have written, such as discussion posts. When submitting work, students must clearly identify any writing, text, or media generated by AI. This can be done by presenting AI generated text or

writing in a different font color. The prompts used with the generative AI tool, as well as the originally written text provided to the generative AI tool must be submitted, also.

### **Classroom Climate of Respect**

Importantly, this class will foster free expression, critical investigation, and the open discussion of ideas. This means that all of us must help create and sustain an atmosphere of tolerance, civility, and respect for the viewpoints of others. Similarly, we must all learn how to probe, oppose and disagree without resorting to tactics of intimidation, harassment, or personal attack. No one is entitled to harass, belittle, or discriminate against another on the basis of race, religion, ethnicity, age, gender, national origin, or sexual preference. Still we will not be silenced by the difficulty of fruitfully discussing politically sensitive issues.

## Assignments

Assignments will **not** be accepted late. Most assignments will be completed through McGraw-Hill's Connect platform and will differ, depending on the chapter. There will usually be two homework assignments per chapter. Some weeks there might be more or less assignments. These assignments will be due on **Friday evenings at 10 p.m.** The assignments for each chapter will open on the Saturday before at midnight, so you will have a full week to complete the assignments. If there are extenuating circumstances that keep you from completing the assignments, please let the instructor know ***BEFORE*** the due date. You have seven days to complete the assignments, so there should be plenty of time to let the professor know of your situation or get the assignments done. Be responsible with your time.

## “Shark Tank” Financial Statement Analysis Project

This will be a group project. You will be placed into groups of 3-5 people by the professor. You will be provided with financial statements for two small businesses that are looking for venture capital funding from your company (think Shark Tank). *You will be responsible for meeting with your fellow classmates via Microsoft Teams or another virtual meeting platform.* You will take the financial statements and perform several different types of analyses to include vertical, horizontal, and ratio analysis. You will need a solid foundation of how to calculate all these types of analyses, which we will learn when we learn about in Chapter 13. The ratios that you will need are found on the separate project guidelines worksheet available to you. This project will be completed with Microsoft Excel and will help to ensure that you are familiar with utilizing the software to format, perform calculations using cell referencing and functions within the spreadsheet, as well as creating graphs in the software to show trends. Once you have completed the analysis of the two companies, you will have to decide as a group which small business you should invest your funds into. You will have to explain your reasoning in a short memo. Additional guidelines on the project can be found in a separate project guidelines document, provided by the professor via Blackboard Ultra.

## Comprehension Opportunities (Exams)

There will be four Comprehension Opportunities throughout the semester. Each Opportunity will test over three chapters, except for the third Opportunity. The third Opportunity will only cover two chapters. The Opportunities have due dates listed on the course schedule. This is the date that the Opportunity is due. The Opportunities will be taken online through Blackboard. They will be open for two days, starting the day before it's due on the course schedule at midnight and will end on the scheduled due date at **10 p.m.** See the course schedule for the due

dates. If you are going to miss a Comprehension Opportunity, please notify the professor as early as possible. We can work together to schedule a time to take the Opportunity. If you have a family or medical emergency, please discuss it with your professor as soon as possible.
