The Research Paper (at least 5 pages) is to be written on a 12 font, using Times New Roman, double spaced, with a one inch margin, and follow APA format. All reports require a cover page, abstract, and references page and do NOT count toward the page requirement.

Please include three (3) sources. Your book does not qualify as a source. Do NOT use Wikipedia and Investopedia.

All research papers are to be submitted by BlackBoard and will be submitted to Safe Assign.

The required format follows:

1. Define what is Environment, Social, and Corporate Governance (ESG)
2. Explain why ESG matters to companies
3. Find a company reporting ESG in its annual financial report and provide an example (please don't forget to provide your reference(s)).
