About Individual Instruction

Students will develop and maintain:

- 1. Balanced posture
- 2. Coordination and dexterity of hands and fingers
- 3. Attention to tone and intonation
- 4. Accurate bowing and fingering techniques
- 5. Intentional musical expression
- 6. Proper care of instrument and equipment
- 7. A consistent practice schedule
- 8. Efficient practice strategies
- 9. Historical knowledge of string instruments, ensembles, and repertoire

General Remarks:

String techniques instruction often incorporates physical contact relating to the positioning of fingers, hands, wrists, and elbows. This is one tool among many, intended solely to support the student's technical progress. It is not a required element of string instruction. The instructor is to ask permission before engaging, and the student should respond at the discretion of their comfort level: yes or no. If there are any concerns, please address them with the instructor directly, or with the Fine Arts Chair, Marjorie Scott.

Assessment

- 60% of the semester grade is based on weekly lesson attendance
- 40% of the semester grade is based upon the student's growth in musical and technical areas.

The level of expectation regarding outcomes will be informed by the student's primary area of study (whether the student is a music major, a music minor, or a student pursuing a non-music degree.)
