**Course Description:** The course is designed to promote examination of evolving concepts and philosophies of agricultural and governmental programming, while applying analytical methods and critical thinking skills in assessing the role of politics in policy making. Students can interpret complex and conflicting data and arguments, evaluate alternative courses of action, and anticipate the consequences of policy choices. Students will learn how to find and interpret policy relevant information and to acquire an understanding of the limitations to what government can do about public problems. Collaborative learning and field experience utilized.**Course Objectives:** The primary purpose of this course is to develop historical and futuristic understanding of entities, theories and concepts impacting public policy related to the agriculture industry globally, nationally, and locally. Upon successful completion of this course, students will:

1. Identify concepts and terminology related to agricultural, food and trade policies;
2. Conceptualize the process by which agricultural policy is developed and implemented;
3. Analyze agricultural, food and trade policies with implications for producers and consumers;
4. Critically examine the need for agricultural policies and policy reforms;
5. Demonstrate knowledge of the interconnectedness of global dynamics in relation to the food and fiber system;
6. Utilize appropriate oral and written responses to realistic situations;

**Course Syllabus:** Due to the organizational nature of the instructor, beyond this point, this syllabus is laid out in alphabetical order by topic. All course members will be participating in the *Connecting with Students for Success* initiative at SRSU with the purpose of engaging students for academic, individual and professional success. #### **Evaluation Components:**

**Attendance:** Attendance will be recorded for each class session. You must be present when the roll is taken in order to earn the points. Percentage will be used to determine attendance points.

**Class Debates:** For each policy level addressed in class, students will work independently to prepare a policy debate examining the multiple perspectives of the policy.

**Agricultural Policy Reflection Essays:** Students will prepare a self-written reflection in 5-paragraph essay format for one of the policies discussed through each content topic area of the course, including global policies, national policies, state/local policies. The grading rubric can be accessed through Blackboard.

**Team Essay:** Students will self-select into teams to examine a particular agricultural policy from multiple perspectives. Each team will prepare a scholarly-based essay incorporating the academic writing format provided in this syllabus. The paper must provide points, subpoints and support for each perspective presented. Paper length should be 6-8 pages, with additional pages for the works cited list. The paper evaluation score will be applied to all team members.

**Team Presentation:** Students will self-select into teams to examine a particular agricultural policy from multiple perspectives. Policies will be assigned by the instructor. The presentation format is detailed on the course website.

**\*Bonus Point Opportunities:** For each of the major policy-level categories listed in the syllabus outline, students may choose to submit IN ADVANCE of the topic discussions one current contentious issue related to that level with a total of three verifiable sources of information related to that policy.

**Examinations:** (midterm and final) Components of the examinations represent different types of test items including, but not limited to, defining, multiple choice, T/F, short answer, problem solving and essay. You will be given the opportunity to make some decisions on which test items to which you respond. Unless prior arrangements are made with the instructor, students will not be allowed to take exams at other than the specified date and time.
