Course Description: This group performs concert band literature. Enrollment is open to all students with permission of the instructor.

Objectives

The Concert Band provides an educational experience and musical outlet for student and community musicians who wish to remain musically active by performing standards of the band literature. Participants will develop musical skills and knowledge through participation, with emphasis on band techniques and the study and performance of a variety of band literature. Individual instrumental skills will be honed while ear training and the nuances of ensemble performance will be developed. Performances will provide an opportunity for students to explore and refine their confidence in a public format.

Materials

Bring a pencil to all rehearsals. Music folders should be placed in your assigned file after rehearsals and returned after the final performance.

Attendance

Ensemble or classroom behavior should promote a healthy teaching/learning environment for positive interaction and exchange. In any ensemble, regular, punctual attendance is expected for the benefit of the ensemble. The Concert Band rehearses on Tuesday evenings from 6:00 - 8:50pm, unless otherwise indicated. You are expected to be present at every rehearsal and performance unless excused. Conflicts in the schedule should be reported in writing to the Music Director.

Grading The semester grade is determined by successful participation in the ensemble, an average of Two Playing Assessments, and successful participation in our performances.

Each category is graded on a 100-point scale:

Playing Assessment #1 20%

Playing Assessment #2 20%

Rehearsal and Performance Attendance; 60%

Playing Assessment (80%) There will be TWO opportunities to submit an assigned excerpt from our repertoire. You will receive a grade based upon your progress as demonstrated by the assignment. In addition to excerpts from our repertoire, scales and musical exercises may be assigned.

5. Ability to create and disseminate basic marketing and public relations materials, as well as resumes, websites, and digital portfolios.
