Course Description: Study of violin performance, techniques, repertoire, and musical expression. See *About Individual Instruction* for further details.

About Individual Instruction

Students will develop and maintain:

1. Balanced posture
2. Coordination and dexterity
3. Attention to tone and intonation
4. Musical expression and phrasing
5. Proper care of instrument and equipment
6. Efficient practice strategies
7. Historical knowledge of string instruments, ensembles, and repertoire

A consistent practice schedule, as assigned, is required for this course. Documentation of this time and process is to be logged in the student's practice journal.

General Remarks:

String techniques instruction often incorporates physical contact relating to the positioning of fingers, hands, wrists, and elbows. This is one tool among many, intended to support the student's technical progress; It is not a required element of string instruction. The instructor will ask the student for consent before technique-centric physical contact is initiated. Students may establish any of the following protocols per their preference: 1) No-contact lessons, 2) Consent must be given for each contact before it is initiated, or 3) Consent is given to contact over the course of the semester. Any concerns may be addressed with the instructor directly, or with the Fine Arts Chair, Marjorie Scott, at any time throughout the course.
