## Course Description

This course focuses on both formal and informal communication within organizations. It also examines how organizations exhibit their organizational climate and culture. This course provides opportunities and tools for students to further develop their communication skills and apply that learning in organizational settings.

4. Select appropriate organizational formats and channels used in developing and presenting business messages.

## Instructional Method

This course is completely (100%) online using an asynchronous format, meaning you complete at your own pace throughout each week. Students are expected login into Blackboard frequently throughout each week to review content and complete required assignments. Students may review and submit material at their own pace each week as long as everything is completed and submitted by the set deadline at the end of each week. A new module will be posted on Monday of each week.

## Course Design

The course is specifically designed to complete a module each week. Each week's module will open on Monday. The study of leadership is a very reflective in practice, as a result, course material is specifically selected and strategically placed to be completed in small increments. It's highly recommended that you complete the weekly modules throughout the week rather than in one setting; however, how you are at liberty to determine what works best for you to complete module material and corresponding assignments.

## Assignments

All assignments should be submitted via Blackboard. All assignments will be given due days and will be due by 11:59pm on the due date.

**Quizzes & Discussion (150 points):** Quizzes and Discussions will be assigned through the modules. Quizzes are designed to assess knowledge from readings while discussions are designed to make you apply information to personal / professional experiences.

**Weekly Assignments (600 points):** Each week students will have an assignment related to the topic of the week. The assignments will vary from papers, case studies, reflections, comparative analysis, and presentations.

**Timely Care Registration (50 points) :** Students will automatically receive 50 points for downloading the university online service TimelyCare. This program will serve as a case study for the Final Project. (Hint: You need it do successfully do the final project). This application is free to all Sul Ross Students.

**Final Project (200 points):** Students will use knowledge acquired from this class and apply to a series of communication assignments related to Timelycare. More information to come.

## Grading Policy

The grading system for this class follows a point-based system. You earn points toward a grade. Final grades are determined by the total points you have earned. The table below is a breakdown of points required per letter grade and point value for each type of assignment.
