COURSE DESCRIPTION

This class is a production workshop in the art of Documentary Filmmaking. Documentaries are unique in the world of film in that the form is wide open, and most often dictated by the discoveries made by the filmmakers in the *process* of making the film. The topics, themes, construction, and resulting films are as varied as the breadth and depth of human experience. Where fiction films are written, planned, and then executed, Documentaries are planned, executed, and only *then* are they written.

In this class, students will plan, produce, and edit individual short documentaries. Any topic is open for the creative process – the focus is on finding the story the student wants to tell, followed by the practical process of turning the story idea into a movie.

Now we've reached the second part of the class. Post Production. Post, as you'll see, is where the heavy lifting of documentary work happens. While the production of the documentary – the shooting – was a major part, the editing of the documentary ultimately determines what story you're telling. Additional shoots or interviews, as well as voiceover recording, are often part of the post production workflow.

Grading Criteria:

A = Exceptional. Demonstrates mastery of material beyond expectation. Professional quality of work. Highest level of scholarship.

B = Above average. Demonstrates mastery of material. Work is of better-than-expected quality, but not quite professional. High level of scholarship.

C = Average. Demonstrates proficiency with material. Work is of amateur quality. Ordinary level of scholarship.

D = Below Average. Less than proficient with material. Work shows errors, careless mistakes, or is just plain wrong. Poor scholarship.

F – Failure. Material incomplete. Work grossly negligent or incomplete. No evidence of scholarship present.

CLASS ATTENDANCE
