Introduction to Business Law

This course provides students with a foundational understanding of the principles, concepts, and applications of business law. It explores the legal framework that governs commercial activities and the role law plays in protecting businesses, consumers, and society. Students will study key areas such as contracts, torts, employment law, intellectual property, consumer protection, property rights, and international business law.

Through real-world examples and case studies — students will learn how the law applies to everyday business transactions and the consequences of legal violations. Ethical considerations and the relationship between law and business decision-making will also be emphasized.

Encourages critical thinking and problem-solving by engaging students in discussions about disputes, regulations, and contemporary issues like data privacy, e-commerce, and globalization. By the end of the course, students will be able to identify legal issues in business scenarios, understand their rights and responsibilities as consumers and future professionals, and appreciate the importance of ethical conduct in business.
