### STATE OF TEXAS VICTIM RIGHTS

#### Reference: Chapter 56 of Texas Code of Criminal Procedure

A victim of crime is defined by Chapter 56 of the Code of Criminal Procedure, as (1) someone who is the victim of sexual assault, kidnapping, or aggravated robbery or who has suffered bodily injury or death because of the criminal conduct of another, (2) the close relative (spouse, parent, adult brother or sister, or child) of a deceased victim or (3) the guardian of a victim. The law also applies to victims of juvenile crime, including victims who suffer property loss.

The State of Texas intends that victims of crime receive the following safeguards, assurances and considerations:

- Receive adequate protection from harm and threats of harm arising from cooperation with prosecution efforts;
- Have their safety considered by the magistrate when setting bail;
- Receive information, on request, of relevant court proceedings, including appellate proceedings, of cancellations and rescheduling prior to the event, and appellate court decisions after the decisions are entered but before they are made public;
- Be informed, when requested, by a peace officer about the defendant's right to bail and criminal investigation procedures, and from the prosecutor's office about general procedures in the criminal justice system, including plea agreements, restitution, appeals and parole;
- Provide pertinent information concerning the impact of the crime to the probation department prior to sentencing;
- Information about the Texas Crime Victims' Compensation Fund and payment for a medical examination for a victim of sexual assault, and, on request, referral to social service agencies that provide additional assistance;
- Information, on request, about parole procedures; notification of parole proceedings and of the inmate's release; and the opportunity to participate in the parole process by submitting written information to the Board of Pardons and Paroles for inclusion in the defendant's file for consideration by the Board prior to parole;
- A separate or secure waiting area at all public court proceedings;
- Prompt return of any property that is no longer needed as evidence;
- Have the prosecutor notify, upon request, an employer that the need for the victim's testimony may involve the victim's absence from work;
- On request, counseling and testing regarding AIDS and HIV infection and testing for victims of sexual assault
- Request victim-offender mediation coordinated by the Victim Services Division of the Texas Department of Criminal Justice;
- Be informed of the use and purpose of a victim impact statement, to complete a victim impact statement and to have the statement considered before sentencing and acceptance of a plea bargain and before an inmate is released on parole.
  - A victim, guardian of a victim, or close relative of a deceased victim may be present at all public court proceedings, with the consent of the presiding judge;
  - A judge, attorney for the state, peace officer, or law enforcement agency is not liable for a failure or inability to provide a service enumerated herein.
  - Victims should also know that they can have a victim advocate accompany them during the sexual assault exam if an advocate is available at the time of the examination.

### STATE OF TEXAS CRIME VICTIMS' COMPENSATION

Reference: Chapter 56 of Texas Code of Criminal Procedure

Crime doesn't pay, but in Texas, criminals do. Texas courts collect court costs from convicted offenders for the Crime Victims' Compensation Fund. If you are a victim of violent crime, you may be eligible for benefits.

Please read the pages on eligibility and reimbursable expenses before filling out an application for Crime Victims' Compensation. Please understand that the statute does not provide for the reimbursement of property damage or losses due to property crimes.

#### **General Program Information**

In 1979, the Texas Legislature passed the Crime Victims' Compensation Act, creating the Compensation to Victims of Crime Fund and the Crime Victims' Compensation (CVC) Program. The primary purpose of the Fund is encouraging greater victim participation in the apprehension and prosecution of criminals and reimbursing innocent victims for certain out-of-pocket expenses incurred as a result of violent crime. The Crime Victims' Compensation (CVC) Program is supported through a legislative appropriation from the Compensation to Victims of Crime Fund. Revenue for the Fund is collected from convicted offenders through criminal court costs, fees, and fines, while victims of violence are assisted with expenses related to the crime. The Fund receives revenue from the following sources:

#### • State Court Costs:

Local governmental submit consolidated court costs to the comptroller for felony and misdemeanor convictions.

#### Parolee Supervision Fees:

Offenders on parole pay \$8 per month to the Fund. The state's parole officers are to be credited for their efforts to collect these fees from parolees.

#### • Donations:

Jurors are provided information about the Fund and are offered the option of donating their daily reimbursements to the Fund.

#### • Subrogation:

By statute, the Attorney General must ask that the victim or claimant reimburse the Fund for the amount paid on behalf of the victim, up to the amount of the civil award, when a crime victim is awarded money in a civil suit.

#### • Federal VOCA Grant :

The federal Victims of Crime Act (VOCA) allows the collection of fines, fees and forfeitures for federal convictions.

#### • Restitution:

Offenders may be ordered to reimburse the Fund for compensation payments made on behalf of those they have victimized.

The Crime Victims' Compensation Program is administered by the Office of the Attorney General and is dedicated to ensuring that victims of violent crime are provided financial assistance for crime-related expenses that cannot be reimbursed by insurance or other sources.

State law requires that reimbursement first be sought from other sources, such as health insurance, Medicaid, Medicare, auto insurance, or Texas Workers Compensation. CVC program staff assists applicants in coordinating the use of all available resources.

Claims may be approved for benefits up to a total of \$50,000. Individuals who suffer total and permanent disability as a result of the crime may qualify for an additional \$75,000, which may be used for specific and limited expenses, such as lost wages, prosthetics, rehabilitation or making a home accessible, depending upon the law in effect on the crime date.

The financial assistance may be limited or unavailable depending on laws in effect when the crime occurred and is dependent upon the applicant providing necessary and required documentation.

### NOTICE TO ADULT VICTIMS OF FAMILY VIOLENCE

### Reference: Chapter 5 of Texas Code of Criminal Procedure

It is a crime for any person to cause you any physical injury or harm EVEN IF THAT PERSON IS A MEMBER OR FORMER MEMBER OF YOUR FAMILY OR HOUSEHOLD.

Please tell the investigating peace officer:

IF you, your child, or any other household resident has been injured; or

IF you feel you are going to be in danger when the officer leaves or later.

You have the right to:

ASK the local prosecutor to file a criminal complaint against the person committing family violence; and APPLY to a court for an order to protect you (you should consult a legal aid office, a prosecuting attorney, or a private attorney). If a family or household member assaults you and is arrested, you may request that a magistrate's order for emergency protection be issued. Please inform the investigating officer if you want an order for emergency protection. You need not be present when the order is issued. You cannot be charged a fee by a court in connection with filing, serving, or entering a protective order. For example, the court can enter an order that:

(1) the abuser not commit further acts of violence;

(2) the abuser not threaten, harass, or contact you at home;

(3) directs the abuser to leave your household; and

(4) establishes temporary custody of the children and directs the abuser not to interfere with the children or any property. A VIOLATION OF CERTAIN PROVISIONS OF COURT-ORDERED PROTECTION (such as (1) and (2) above) MAY BE A FELONY. CALL THE FOLLOWING VIOLENCE SHELTERS OR SOCIAL ORGANIZATIONS IF YOU NEED PROTECTION:

Pídale al fiscal local que presente una denuncia penal contra la persona que comete violencia familiar; y SOLICITE en un tribunal una orden para protegerlo (debe consultar a una oficina de asistencia jurídica, a un fiscal o a un abogado privado). Si un miembro de la familia o del hogar lo agrede y lo arrestan, puede solicitar que se emita una orden de protección de emergencia de un magistrado. Por favor, informe al oficial de investigación si desea una orden de protección de emergencia. No es necesario estar presente cuando se emite la orden. Un tribunal no puede cobrarle una tarifa en relación con la presentación, notificación o entrada de una orden de protección. Por ejemplo, el tribunal puede ingresar una orden que:

(1) el abusador no cometa más actos de violencia;

(2) el abusador no lo amenace, hostigue ni se ponga en contacto con usted en su hogar;

(3) ordena al abusador que abandone su hogar; y

(4) establece la custodia temporal de los niños y le ordena al abusador que no interfiera con los niños o cualquier propiedad.

Title IX of the Education Amendments of 1972 prohibits sex discrimination in educational programs and activities. No person in the United States shall, on the basis of sex, be excluded from participation in, be denied benefits of, or be subjected to discrimination under any education program of activity receiving Federal financial assistance. Texas Law also prohibits gender discrimination and sexual harassment.

Sexual harassment (which includes sexual violence and assault) is a form of sex discrimination and therefore a violation of Title IX. Specific behaviors that are prohibited by Title IX include rape, sexual

### <u>What is Sexual</u> <u>Misconduct?</u>

**Broad Term:** Encompassing a range of non-consensual sexual activity or unwelcome behavior of a sexual nature. The term includes, but is not limited to Sexual Assault, Sexual **Exploitation**, Sexual **Intimidation, Sexual** Harassment, Domestic Violence, Dating Violence and **Stalking. Sexual Misconduct** can be committed by men or women, strangers or acquaintances, and can occur between people of the same or opposite sex.

assault, sexual battery, sexual exploitation, and other form of non-consensual sexual activity; stalking; and relationship violence. Many behaviors that violate Title IX also constitute crimes. Complainants have the right to notification of options for interim safety measures, if requested and if changes are
